1 Introduction and Welcome from Georgie Bigg (Chair)

Georgie welcomed everyone to the Healthwatch North Somerset AGM and introduced the Board of Directors and the team.

2 Election of Directors. Election of New Director

The following five existing Directors were re-elected as per Healthwatch North Somerset Articles of Association which states that at least three Directors must be re-elected (in alphabetical order) at each AGM:-

A proposal to elect Gerry Wadham to the Board of Directors was made by Georgie Bigg and was seconded by Celia Henshall. Members were ask to agree the proposal.

Members voted unanimously to re-elect the Board of Directors and to elect Gerry Wadham to the Board.

3 Presentation of Finance report

DW presented the draft annual Statement of Accounts 2016/17. He outlined that the core grant reduction had been 5% in this period. Direct expenditure costs dropped in the area of salaries, events and meetings, publicity and marketing and use of consultancy and agency. DW said support costs were also lower in 2016/17 and there was a spend on two partnership projects; Heart of Weston Central Ward project and a project run by The Diversity trust.

Questions were invited from the attendees

- Q1. ML What was the amount on the Central Ward project actually for?
- A. It was a project carried out to assess access to Health and Social Care services for people in the Ward. Vicky Marriott undertook the project on a freelance basis she can give more details at the end.
- Q2. What are the salaries of the staff at Healthwatch North Somerset?
- A. The total spend is seen on the slide and that is equivalent to 3.5 FTE salaries as 4 of the 5 staff work part-time.

4 Presentation 1.

You can run but you can't hide from Social Media

6 Presentation 3.

Presentation of the 2016/2017 HWNS Annual Report

Eileen Jacques Chief Officer for Healthwatch North Somerset

Reflecting on the Healthwatch North Somerset Annual Report EJ outlined the work carried out by staff and volunteers in the past year. EJ outlined the work on monthly intelligence and special reports and where they are sent.

Q1 AS asked what do you do if provider does not respond to Healthwatch North Somerset recommendations or get back to us after they get the intelligence?

EJ said we seek responses from all providers and commissioners. We are looking at how we can

find out how providers and commissioners may have made changes after receiving the public feedback.

EJ thanked the team, the Board of Directors and Volunteers for their hard work and support.

7 Presentation 4.

Patient and Public Involvement

Mary Adams PPI Lead for the BNSSG CCGs

MA outlined the changes occurring to the North Somerset CCG; plans towards a BNSSG merger in April 2018 and the move towards closer collaboration and a single commissioning voice. MA explained the ways PPI in which Primary Care seeks to engage with the public over service change. She outlined further opportunities that will be created such as a Patient and Public Engagement Forum. MA mentioned the 'Heathy Weston' publication on the NS CCG website and outlined plans for public engagement over draft proposals for joining up services for better care in Weston.

Q1 JT asked what is the difference between the BNSSG and the old Avon arrangement for me as a patient?

MA said the BNSSG would improve the reach of current services, strip out variation, provide better value for money. She said they are still putting the top team together but one name on the top table is Colin Bradbury from the CCG in North Somerset.

MB said 100% GPs are behind the merger. People in NS regularly use the acute hospitals of Bristol as well as Weston already. NHS England have appointed a new Chair of the STP, the former Chief Executive of Guy's and St Thomas' Foundation Trust, Sir Ron Kerr. Lisa Manson of NHS Improvement is to head up contracts for the BNSSG. By next year there will be two localities in North Somerset, one in the North and one the South and each will have a clinical leader who will be represented on the governing body.

The presenters explained the reason for the Prioritisation Panel, the members who are part of it, the times it meets and the public accessibility. SS outlined the responsibility of the Panel and projects that were carried out at Healthwatch North Somerset as a result of the Panels work.

KM gave details of how in the past year Healthwatch North Somerset has ensured that local people have a voice about health and social care services. KM outlined how outcomes and success from our engagement activities are shown not only in the numbers of pieces of feedback on services but also through the changes that providers have told us they have made as a result of report recommendations or letters.
